

GOLD LEVEL MEMBERSHIP OFFICE LICENSE

THIS GOLD LEVEL MEMBERSHIP OFFICE LICENSE (this “License Agreement”), is made and entered into this March __, 2020 by and between **SynerG, LLC d/b/a SynerG Law Complex**, a Georgia limited liability company, hereinafter called “SynerG” and _____ a member of the Georgia bar, hereinafter called “Licensee”. SynerG hereby grants Licensee a limited revocable license to use of the facilities and common areas at the SynerG Law Complex located at 6075 Barfield Road, Atlanta, Georgia.

Nature of this agreement: This agreement is the commercial office equivalent of an agreement for accommodation(s) in a hotel. The whole of the Complex remains in the SynerG’s possession and control. **THE LICENSEE ACCEPTS THAT THIS AGREEMENT CREATES NO TENANCY INTEREST, LEASEHOLD ESTATE OR OTHER REAL PROPERTY INTEREST IN THE LICENSEE’S FAVOR WITH RESPECT TO THE ACCOMMODATION(S).** This agreement is personal to the Licensee and cannot be transferred to anyone else without prior consent from SynerG.

Licensee agrees to pay SynerG, at the above address, a monthly fee of \$575.00 per month in advance before the first day of each month, commencing on _____ 1, 2020. Licensee agrees to a minimum three-month term, and then will continue month to month after the first three months. After the first two months, either party may terminate this License by giving thirty days written notice to the other party. This term has been modified as provided in Addendum A. Licensee shall pay a security deposit of \$575.00 to be held for unpaid rent or damage to the property.

The Licensed Premises shall be available Monday through Friday, 8:30 a.m. to 5 p.m., with after-hours access available by key card.

SynerG shall provide all of the services advertised under “SynerG’s Gold Membership” for the at <http://www.synergylawcomplex.com>. This Gold Membership Level License provides all the features identified above including 20 hours per month of dedicated private office space plus up to 20 hours per month in meeting rooms or conference rooms. Member must use SynerG app to reserve time in office/meeting/conference rooms. Licensee shall be permitted to use our dedicated Gold Membership shared offices, meeting and conference rooms a la carte for additional hours as follows: \$15.00 per hour for private office space, \$20 per hour for meeting rooms, and \$35 per hour for executive conference rooms. This License will also include a license to use SynerG’s content-rich national Westlaw plan at no additional charge.
